

**GALILEE BEACH CLUB ASSOCIATION**  
**FIRE-PIT RELEASE AND INDEMNIFICATION AGREEMENT**

WHEREAS, the Galilee Beach Club Association (hereinafter "Galilee Beach Club") owns and operates a beach club in Narragansett, Rhode Island; and

WHEREAS, \_\_\_\_\_ is an owner/member of the Galilee Beach Club Association (hereinafter "Owner/Member"); and

WHEREAS, the Owner/Member desires to utilize a fire-pit provided by the Galilee Beach Club on the property owned by the Galilee Beach Club for the payment of a fee; and

WHEREAS, to induce the Galilee Beach Club to allow the Owner/Member to utilize the fire-pit on its property, the Galilee Beach Club requires that this Release and Indemnification Agreement be executed.

NOW, THEREFORE, in exchange for mutual consideration, the receipt and adequacy of which is hereby acknowledged, the Galilee Beach Club and the Owner/Member agree as follows:

The Owner/Member, their representatives, beneficiaries, agents and their respective successors and assigns, do hereby release, acquit and forever discharge the Galilee Beach Club Association and its principals, heirs, executors, administrators, officers, directors, employees, agents, successors, assigns and subsidiaries and subcontractors from any and all claims, debts, demands, actions, causes of actions, suits, dues, sums and sums of money, accountings, covenants, contracts, contract claims, executions, post-judgment actions, controversies, agreements, promises, doings, omissions, variances, damages, liabilities and judgments of whatsoever nature, both at law and in equity, whether accrued or unaccrued, whether known or unknown, which said Owner/Member ever had or may have against the said Galilee Beach Club Association and its principals, heirs, executors, administrators, officers, directors, employees, agents, successors, assigns and subsidiaries and subcontractors arising out of or in any way relating to the use of the fire-pit in question including, but not limited to, bodily injury that may arise out of the same.

In addition, the Owner/Member shall indemnify, defend and hold harmless the Galilee Beach Club Association and its principals, heirs, executors, administrators, officers, directors, employees, successors, assigns, agents, subsidiaries and subcontractors from any and all claims, debts, demands, actions, causes of actions, suits, dues, sums and sums of money, accountings, covenants, contracts, contract claims, executions, post-judgment actions, controversies, agreements, promises, doings, omissions, variances, damages, liabilities and judgments of whatsoever nature, both at law and in equity, whether accrued or unaccrued, whether known or unknown, which any third party ever had or may have against the Galilee Beach Club Association and its principals, heirs, executors, administrators, officers, directors, employees, successors, assigns, agents, subsidiaries and subcontractors, arising out of or in any way relating to the use of the fire-pit in question, including but not limited to injury to said third parties.
